

DICE RUN DIRECTIONS

All turns and stops will be announced on CB channel number 3.

1. Exit AutoZone/Food Lion parking lot to the right on to **Pine Street**.
2. Turn Left on to **White Pond Road** travel for **2.9** miles.
3. Turn left onto **I-20 East** on ramp and merge onto **I-20 East** and travel for **10.6** miles.
4. Take exit ramp **number 98** to **US 521**.
5. Turn left on **US 521/Broad Street** and travel for **2.9** miles.
6. Turn left onto **Rutledge Street**.
7. Take first right to **Commerce Ally** and park in parking lot.

Approximate Arrival 12:00 (First Sponsor Stop Hifalutin Restaurant) Approximate Depart 1:00

8. Exit the parking lot to the left onto **Rutledge Street**.
9. Turn to the left onto **US 521/Broad Street** travel one block and turn to the left onto **US 1**.
10. Travel 3.5 miles and merge to the right onto **Long town Road** and travel for **22.8** miles.
11. Turn to the left onto **US 21/HWY 34** Park on sides of street.

Approximate Arrival 1:30 (Second Sponsor Stop Laura's Tea Room) Approximate Depart 2:30

12. Continue on **US 21/HWY 34** for **0.3** mile and bear to the right onto **US 21/ Wilson Blvd.** and travel for **6.9** miles.
13. Turn to the right onto **Blythewood Road** turn right onto **McNulty Street**.

Approximate Arrival 2:45 (Third Sponsor Stop Chuggers) Approximate Depart 3:45

14. Turn left out of parking lot onto **McNulty Street** cross **Boney Road** and turn right at stop sign.
- 15 Turn 1st left **Langford Road** and travel for **4.0** miles.
16. Turn right onto **Hardscrabble Road** and travel for **0.8** miles.
17. Turn left on to **Kelly Mill Road** and travel for **4.8** miles.
18. Turn to the right onto **Bookman Road** and travel for **2.0** miles.
19. Cross **US 1** to **Spears Creek Church Road** and travel for **1.8** miles.
20. Turn Right onto **Pontiac Business Center Drive** and park in big parking lot at Thunder Tower.

Approximate Arrival 4:15 (Fourth Sponsor Stop Thunder Tower Harley Davidson) Depart 4:45

21. Circle around Thunder Tower Harley Davidson and turn right onto **Spears Creek Court**.
22. At the stop sign turn right onto **Spears Creek Church Road**.
23. At the Traffic light turn to the left onto **I-20 East** on ramp and merge onto **I-20 East** and travel for **4.9** miles.
24. Take exit ramp **number 87** to **White Pond Road** turn to the left at stop sign and travel for **2.9** miles.
25. Turn to the right onto **Pine Street** go to AutoZone/Food Lion parking lot.

Arrive at Approximately 5:00
